Wood Duck Boxes

OCTOBER 2024

Wood ducks and other waterfowl typically nest in large tree cavities adjacent to wet habitats that provide sufficient food. Once threatened with near-extinction in the early to mid-20th century, these birds have experienced a healthy population rebound, in part due to nest boxes creating new nesting opportunities. The PUD maintains over 35 waterfowl nest structures as part of the Box Canyon Hydroelectric Project license compliance efforts.

The PUD offers technical support to local groups and individual landowners that are interested in enhancing waterfowl nesting habitats in shoreline areas located within the Box Canyon reservoir. The PUD also offers a limited number of structures for cavitynesting waterfowl. For either technical assistance or a cavity nest structure, contact the PUD at <u>information@popud.org.</u>

PEND OREILLE PUD DEVELOPING **COMPREHENSIVE WILDFIRE MITIGATION PLAN**

The PUD is actively developing its Wildfire Mitigation Plan in response to evolving wildfire risks and new regulatory requirements in Washington State. With a submission deadline of October 31, 2024, the plan focuses on protecting communities and electrical infrastructure, reducing potential wildfire impacts, and complying with state regulations. The PUD's approach includes evaluating vegetation management, updating equipment, and other risk mitigation measures while balancing customer needs and financial responsibility.

"This is an important step in ensuring that our county and the surrounding environment are protected from the increasing risks posed by wildfires," said Joe Hathaway, Public Information Officer for the PUD. "Our goal is to integrate best practices into our operations and maintain a resilient electrical system, while staying committed to providing reliable and affordable service to our customers."

Following the plan's submission, the PUD is committed to engaging the community through public meetings where residents will have the opportunity to learn more about the finalized plan, ask questions, and provide input on wildfire mitigation efforts. These meetings are expected to take place next spring.


