HELP US BRANCH OUT OF HARM'S WAY

Trees and power lines don't mix, and with wildfire risk on the rise, the PUD needs your help spotting trouble before it strikes.

If you have dead or dying trees on your property that could fall into power lines, let us know. Pend Oreille PUD offers free removal of trees that are within striking distance of power lines and free safety trims for branches within 10 feet of energized lines.

But it's important to note: We don't trim or remove every tree near a power line—only those that pose a safety hazard. That means trees that are dead, dying, structurally compromised, or showing signs of failure that could bring them down on our infrastructure.

These efforts are part of our wildfire mitigation strategy, which runs year-round - not just during fire season.

Pend Oreille PUD serves more than 10,000 meters across 1,400 square miles of mostly forested terrain. With that kind of footprint, we can't see every hazard on our own, but you can help.

FIRE DISTRICTS IN PEND OREILLE COUNTY URGENTLY NEED VOLUNTEER SUPPORT

Volunteer fire departments across Pend Oreille County are calling on community members to step up and serve. From Fire District 2 in the north to Districts 4 and 5 in the central county, and South Pend Oreille Fire and Rescue, local departments are in critical need of volunteers—not just firefighters, but EMTs, drivers, support staff, and more.

Nationwide, the number of volunteer firefighters has declined sharply over the past few decades. According to the National Volunteer Fire Council, volunteer firefighter numbers have dropped from nearly 900,000 in the 1980s to fewer than 700,000 today—even as calls for service have nearly tripled. Washington State has seen similar trends, especially in rural areas like Pend Oreille County where volunteers are often the only line of defense against wildfires and emergencies.

Most local districts offer training, equipment, and support for those willing to serve. No prior experience is necessary—just a commitment to helping neighbors in need. "We welcome volunteers who want to be part of a community focused organization for both operational and non-operational roles," said Lawsandra Kramer, Chief of POC Fire District 5. "We make a difference while having fun."

At Pend Oreille PUD, we know that safety is a shared responsibility. We proudly support our local fire partners and encourage community members to consider volunteering. "Volunteer fire organizations play a critical role in ensuring the safety of rural communities," said Joe Hathaway, Public Information Officer for the PUD. "They serve as the front line of defense between our residents and the devastation that often accompanies wildfires."


